# Board of Trustees Regular Meeting October 19, 2011 – 7 p.m.

#### A. Roll Call

President Megaridis called the meeting to order at 7:03 p.m. Secretary Suriano called the roll. Present: Marian Krupicka, Crystal Megaridis, Paul Oggerino, Jo Ann Schusterich, Luanne Spiros, Victoria Suriano

President Megaridis asked for additions and/or corrections to the agenda. There were none.

B. <u>Mission Statement</u>: Secretary Suriano read the library mission statement. We enrich peoples' lives by providing opportunities to explore, connect, and be inspired.

Our community depends upon the Indian Prairie Public Library District as a vital and trusted resource for achieving personal goals and enhancing quality of life. Suriano moved, Krupicka seconded to set the Omnibus Consent Agenda. Roll call vote. Motion carried unanimously. Oggerino moved, Schusterich seconded to approve the Omnibus Consent Agenda. Motion carried unanimously.

## G. Library Director's Report

Bukovac reported that the census figure has changed from 43,879 to 42,529. Bukovac noted that in the 2010 census there was a small increase in seniors and less children which was represented by an increase in single and two person households. Krupicka asked if the new Loyola facility is paying taxes; Bukovac will check with Burr Ridge. With respect to the Burr Ridge Community Service Survey, Megaridis commented that she counted 55 people wanting a library and they thought it should be free. Bukovac said that it is part of our strategic plan to educate the residents of Burr Ridge about library service; she will follow up with the Village as to what the discussion was at their recent meeting. Krupicka asked if Burr Ridge can contract for library service. Bukovac will look into this with the State Library and will also ask the State Library what, if any, other options are available for Burr Ridge. Spiros said that this topic has come up many times and she would like us to talk with the Burr Ridge leadership about the available options and the coordinating processes. Bukovac pointed out that we have communicated with them about this issue; the officials understand that in order to get library service, the residents or the Village would have to pay for it on their tax bill but the residents don't understand how it works and we need to educate them on it. Suriano said that regardless of what the residents are asking for, they would have to get the commitment from their Village to support it financially. Bukovac said that after she discusses the issue with the State Library, we can give the information to the Village and then determine how to communicate with the residents. With respect to SWAN, Bukovac reported that they are starting to work on their budget (some libraries start their fiscal year in January) and are keeping an eye on what RAILS is doing. SWAN feels that the facility consultant RAILS used and the report that was prepared did not adequately address the needs of a computer consortium like SWAN so the 4 directors of the 4 computer consortiums are working together to evaluate the facilities themselves in terms of what is needed for a data center. SWAN is also concerned about personnel salaries. There is a discussion going on between RAILS and the State Library regarding this issue and there is talk of slashing salaries. With their budget discussion, SWAN will be taking a look at the possibility of paying the SWAN employees themselves. Birmingham reported that as of today, 113 tickets have been sold for Dancin' in the Stacks.

There are also key priorities that fall under each initiative and in some cases there are specific action steps for moving the initiative forward. Bukovac feels that the fundamental resources are key for 2011. She pointed out that there will be action steps under marketing but they haven't gotten that far yet. Bukovac asked the Trustees if they had other ideas. Spiros mentioned studying

privatization in terms of libraries. Bukovac will provide the Trustees with information on this topic. Spiros suggested the computer classes we offer may qualify as continued education/certification. Megaridis said she'd like to see more advanced computer classes offered.

2. Trustee Vacancy – At 8:10 p.m. Spiros moved, Suriano seconded to go into Closed Session as allowed by 5ILCS, Act 120/2 (c) (3) The selection of a person to fill a public office, as defined in the Open Meetings Act, including a vacancy in a public office, when the public body is given power to appoint under law or ordinance, or the discipline, performance or removal of the occupant of a public office, when the public body is given power to remove the occupant under law or ordinance. Roll call vote. Ayes: Krupicka, Megaridis, Oggerino, Spiros, Schusterich, Suriano. Nayes: None. Absent: None. Motion carried unanimously.

At 8:25 p.m. Suriano moved, Schusterich seconded to go back into open session. Roll call vote. Motion carried unanimously. Suriano moved, Krupicka seconded to appoint Robert Thomas as Trustee. Motion carried unanimously. Megaridis stated that she will contact Robert Thomas to ask him to fill the Trustee vacancy. She will also contact Robert Vuillaume to let him know the outcome.
